I am very heavily involved in DMR and particularly Motorola's version, MotoTRBO, hence the vanity callsign, K1DMR.

I am interested in any form of Radio Over IP (RoIP) or Voice Over IP (VoIP), both analog and digital.

I am also interested in interoperability between and amongst various other analog and digital protocols.

I am particularly interested in the above because of their application for Emergency Communications.

I am currently using Motorola MOTOTRBO (DMR) as best in breed for my public safety activities, all of the same features as P25 for a fraction of the cost (not sure who needs 256 bit encryption, and in most cases is illegal to use, especially on Amateur Radio).

I concentrate on the VHF and UHF bands because of its availability in hand held radios.

I am a former British Police Officer, former US Federal Agent, and a Firefighter in GA and NC. Over the years, I have been heavily involved in ARES/RACES and served as EC for several different jurisdictions.

I am an Emergency Management professional and has been involved in the planning, mitigation, evacuation, incident response, damage assessment, and disaster assistance and recovery services for a major metropolitan county in the U.S. encompassing 2,430 square miles with a population of 2.2 million.

Some of the positions I have held in the public sector include: Presidential Staff member for planning and logistics to the White House Advance during the Reagan, Bush and Clinton Administrations; Chairman of a public service group attached to the Emergency Operations Center of the Miami-Dade County, Office of Emergency Management; a FEMA program Officer, for the City of Coral Gables, Florida, Division of Emergency Management; an Emergency Response Team member to the Miami-Dade Fire Rescue Department; a member of the Disaster Response Team of the American Red Cross, and a Emergency Services Staff Officer in both the U.S. Coast Guard and the U.S. Air Force Auxiliaries.

During this time, I had actual hands on experience in effectively dealing with large scale business disruptions and disaster recoveries. Some of the business disruption incidents he has managed have included acts of employee sabotage, bomb threats, work place violence, and labor unrest. Some of the disaster recovery operations he has been involved in were wide area fires and flooding, tornadoes and hurricanes.

I possess a Master of Science Degree in Criminal Justice, summa cum laude, and am a graduate of the U.S. Federal Emergency Management Agency's (FEMA), Emergency Management Institute.
